3. Composition/information on ingredients

Methods for cleaning up

- Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.
- Large spill** : Stop leak if without risk. Dike spill area and do not allow product to reach soil, surface water, ground water or sewers. Contain and collect spillage with non-combustible, absorbent material and place in container for disposal.

7. Handling and storage

- Handling** : Avoid inhalation or contact with skin, eyes or clothing. Avoid container breakage. Do not contaminate water sources when disposing of equipment washwater or rinsate. Keep out of lakes, stream or ponds. Keep out of reach of children.

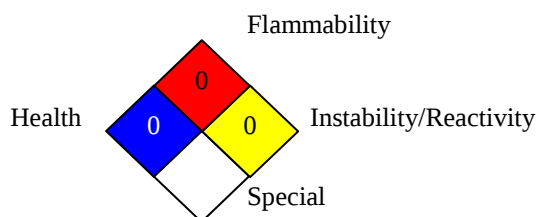
